Subject: Annual Proposed Acceptable Knowledge Sufficiency Determination List

Dear Mr. Kieling:

Pursuant to Permit Attachment C, Section C-0b, Acceptable Knowledge Sufficiency Determination (AKSD), the Permittees are required to submit to the New Mexico Environment Department (NMED) a list of waste streams which the Permittees may submit for AKSD concurrence during the upcoming federal fiscal year. The Permittees are planning one waste stream for the upcoming federal fiscal year 2013:

- IN-ID-BTO-030: A remote-handled transuranic homogeneous solids waste stream

This remote-handled transuranic homogeneous solids waste stream consists of inorganic waste materials generated during sectioning of fuel elements, and the grinding, mounting, and polishing of metallographic specimens at Bettis Atomic Power Laboratory (BAPL). This waste was shipped from BAPL to the Idaho National Laboratory for characterization and packaging.

Furthermore, the Permittees are removing waste stream SR-RL-BCLDP.001 from the fiscal year 2012 submittal of the Annual Proposed Acceptable Knowledge Sufficiency Determination List, (DOE Memorandum CBFO: OESH: GTB:ANC:11:0781:UFC 5822.00 from E.J. Ziemianski and M.F. Sharif to Mr. John Kieling, dated June 22, 2011, subject Annual Proposed Acceptable Knowledge Sufficiency Determination List). The Permittees will not submit the associated AKSD in federal fiscal year 2012 for concurrence by the NMED, as the Permittees are not currently performing characterization activities at Hanford, the location of this waste stream. The Permittees may resubmit this waste stream in a future Annual Proposed Acceptable Knowledge Sufficiency Determination List in accordance with Permit Attachment C, Section C-0b, *AK Sufficiency Determination*.

We certify under penalty of law that this document and all attachments were prepared under our direction or supervision according to a system designed to assure that qualified personnel properly gather and evaluate the information submitted.
