The New Mexico Environment Department (NMED) hereby approves with changes the permit modification request (PMR) to the WIPP Hazardous Waste Facility Permit as submitted to the Hazardous Waste Bureau in the following document:

- Request for Class 2 Permit Modification (Revise Waste Analysis Plan Waste Characterization Methods), Letter Dated December 12, 2012, Received December 14, 2012

This Class 2 PMR was evaluated and processed in accordance with the requirements specified in 20.4.1.900 NMAC (incorporating 40 CFR §270.42(b)). The Class 2 PMR was subject to a 60-day public comment period running from December 18, 2012 through February 18, 2013.

Pursuant to 20.4.1.900 NMAC (incorporating 40 CFR 270.42(b)(7)(i) and (ii)) NMED hereby approves this modification with changes as noted in the attached CD-ROM. 
