

The corrective action to provide a tailgate briefing to training personnel and training to on-the-job training (OJT) instructors on the process to review/revise and complete training records is deemed appropriate; however, due to the volume of records errors found during CBFO Audit A-15-01, an on-site CBFO surveillance will be conducted to perform closure verification.
