Dear Messrs. Shrader and Breidenbach:

The New Mexico Environment Department (NMED) acknowledges receipt of a Class 1 permit modification notification pertaining to the WIPP Hazardous Waste Facility Permit. The notification informed NMED of the following Class 1 Permit Modification: Revise Attachment A, Section A-1, *Facility Description* to Change the Department of Energy, Carlsbad Field Office Manager. This modification also changes the facility telephone number in Attachment A, Section A-1. The notification letter was dated October 8, 2015 and was received on October 9, 2015.

The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC require the assessment of fees. The fee invoice is attached to this letter. Payment is normally due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. However, because NMED submitted an assessment of supplemental permit fees to the Permittees for the current State fiscal year, and the
