Dear Messrs. Shrader and Breidenbach:

The New Mexico Environment Department (NMED) acknowledges receipt of a Class 1 permit modification notification pertaining to the WIPP Hazardous Waste Facility Permit. The notification informed NMED of the following Class 1 Permit Modification: *Six (6) Items: 1) Technical Training Organizational Change; 2) Descriptive Changes Regarding Ventilation Configurations; 3) Update Resource Conservation and Recovery Act Emergency Coordinator List; 4) Update Chronology in Attachment A; 5) Revise a Procedure Number in Attachment E, Table E-1a; and 6) Update the Underground Ventilation System Description.* The notification letter was dated February 17, 2016 and was received on February 19, 2016.

The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC require the assessment of fees. The fee invoice is attached to this letter. Payment is normally due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. However, because NMED submitted an assessment of supplemental permit fees to the Permittees for the current State fiscal year, and the


