The New Mexico Environment Department (NMED) acknowledges receipt of a Class 1 permit modification notification pertaining to the WIPP Hazardous Waste Facility Permit. The notification informed NMED of the following Class 1 Permit Modifications: 1) *Revise and Update Inspection Schedule/ Procedures*, 2) *Revise and Update Personnel Training*, 3) *Revise List of Resource Conservation and Recovery Act Emergency Coordinators*, 4) *Revise List of Emergency Equipment*, and 5) *Revise Incident Commander Description and Associated Training*. The notification letter was dated December 6, 2016 and was received on December 7, 2016.

The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC require the assessment of fees. The fee invoice is attached to this letter. Payment is normally due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. However, because NMED submitted an assessment of supplemental permit fees to the Permittees for the current State fiscal year, and the


