The New Mexico Environment Department (NMED) acknowledges receipt of a Class 1 permit modification notification pertaining to the WIPP Hazardous Waste Facility Permit. The notification informed NMED of the following Class 1 Permit Modifications: *1) Update the Co-Permittee Project Manager and the list of active Environmental Permits.* The notification letter was dated June 12, 2017 and was received on June 14, 2017.

The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC require the assessment of fees. The fee invoice is attached to this letter. Payment is normally due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC.
