The New Mexico Environment Department (NMED) acknowledges receipt of the *Transmittal of the Final Report for CBFO Audit A-17-17 of the LANL/CCP*. The audit report cover letter was dated August 7, 2017 and was received by the NMED on August 9, 2017.



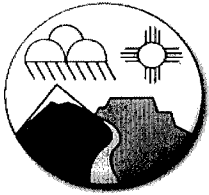
