Dear Messrs. Shrader and Covert:

The New Mexico Environment Department (“NMED”) acknowledges receipt of four Class 1 Permit Modification Notifications (“Modifications”), not requiring prior approval, to the Waste Isolation Pilot Plant Hazardous Waste Facility Permit (“Permit”). The Department of Energy’s Carlsbad Field Office (“DOE”) and Nuclear Waste Partnership (“NWP”) (collectively “the Permittees”) submitted the following Modifications respectively:

- Five Item Class 1: Dated December 6, 2016 and received December 7, 2016:
 - 1) Revise and Update Inspection Schedule/Procedures in Attachments E and O;
 - 2) Revise and Update Personnel Training in Attachments F, F1, and F2;
 - 3) Revise List of RCRA Emergency Coordinators in Attachment D, Table D-1;
 - 4) Revise List of Emergency Equipment in Attachment D, Table D-2; and
 - 5) Revise Incident Commander Description and Associated Training in Attachments D and F1.

- One Item Class 1: Dated December 15, 2016 and received December 19, 2016:
 - 1) Revise Emergency Shower Location in Attachment D, Table D-2.


- One Item Class 1: Dated June 12, 2017 and received June 14, 2017:
