

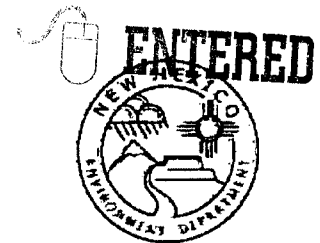

Dear Messrs. Shrader and Covert:

The New Mexico Environment Department (NMED) acknowledges receipt of a Class 1 Permit Modification Notification pertaining to the WIPP Hazardous Waste Facility Permit. The Notification informed NMED of the following Class 1 Permit Modifications: 1) *Editorial Correction in Attachment A4, Section A4-3*; 2) *Update to Attachment E, Table E-1*; and 3) *Add Live Fire Extinguisher Refresher Training to Attachment F2*. The notification letter was dated October 6, 2017 and was received on October 10, 2017.

The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC require the assessment of fees. The fee invoice is attached to this letter. Payment is normally due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. However, because NMED submitted an assessment of supplemental permit fees to the Permittees for the current State fiscal year, and the


