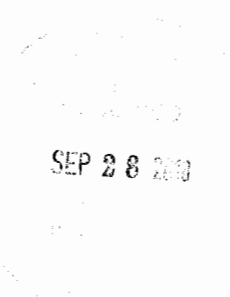

NOTICE OF HEARING

On September 25, 2018, the New Mexico Environment Department, Hazardous Waste Bureau (HWB), filed a Notice of Completeness Determination for the Class 3 Clarification of TRU Mixed Waste Disposal Volume Reporting Permit Modification to the WIPP Hazardous Waste Facility. The Cabinet Secretary of the New Mexico Environment Department, Butch Tongate, appointed Max Shepherd, to serve as Hearing Officer in this matter pursuant to 20.1.4.100(E)(2) NMAC.
