The New Mexico Environment Department (NMED) acknowledges receipt of the *Transmittal of the Final Report for CBFO Audit A-18-13 of the Oak Ridge National Laboratory/Central Characterization Program (ORNL/CCP)*. The audit report cover letter was dated July 10, 2018 and was received by the NMED on July 13, 2018.


