The New Mexico Environment Department (NMED) acknowledges receipt of the *Transmittal of the Final Report for CBFO Audit A-19-06 of the Idaho National Laboratory/Central Characterization Program (INL/CCP)*. The audit report cover letter was dated March 25, 2019 and was received by the NMED on March 26, 2019.


