#### **Overview of the Permit Modification Notification**

This document contains a Class 1 Permit Modification Notification (**PMN**) for the Waste Isolation Pilot Plant (**WIPP**) Hazardous Waste Facility Permit (**Permit**) Number NM4890139088-TSDF.

This PMN is being submitted by the U.S. Department of Energy (**DOE**) and Nuclear Waste Partnership LLC, collectively referred to as the Permittees, in accordance with Permit Part 1, Section 1.3.1. (20.4.1.900 New Mexico Administrative Code (**NMAC**) incorporating Title 40 of the Code of Federal Regulations (**CFR**) §270.42(a)). The PMN in this document is necessary to notify the New Mexico Environment Department (**NMED**) of changes which impact the Permit. These changes do not reduce the ability of the Permittees to provide continued protection to human health and the environment.

The modification to the Permit and any related supporting documents are provided in this PMN. The proposed modifications to the text of the Permit have been identified using red text and <u>double underline</u> and a strikeout font for deleted information. All direct quotations are indicated by italicized text.


#### Discussion

On August 9-10, 2022, the NMED inspected Panel 8. On August 31, 2022, the NMED notified the Permittees of their concurrence that Panel 8 has been constructed in compliance with the requirements of the Permit. Panel 8 is now available for waste emplacement and is an authorized HWDU. Permit Figures A2-1, A4-4, A4-4a, B3-2, D-3, D-4, D-7, G-1, G-6, and G2-1 have been updated to indicate that Panel 8 is certified. An editorial change was made to Permit Figures A4-4 and A4-4a to make the line colors consistent with other figures in the Permit. Note that Permit Attachment G, Table G-1, *Anticipated Earliest Closure Dates for the Underground HWDUs* will be updated with the Permit modification to notify the NMED of the final TRU mixed waste volume emplaced in Panel 7 pursuant to Permit Part 6, Section 6.10.1.

Permit Attachment K, Table K-4 has also been updated to reflect the use of Panel 8 as an authorized HWDU. In addition, Permit Attachment N, Figure N-4b has been updated to reflect the approximate locations of the volatile organic compound sampling head intake lines. The note was added to Figure N-4b to be consistent with the note on Figure N-4a and to make it clear that the figure is not to scale and is for illustrative and informational purposes. These changes are needed to update the Permit with current information related to the completed construction and authorization to use Panel 8.

For clarity, red boxes are provided on the versions of the figures being replaced to depict the exact areas where changes are being made.





Figure A2-1 Repository Horizon







Figure A4-4 Typical Underground Transport Route Using E-140







Figure A4-4a Typical Underground Transport Route Using W-30





Figure B3-2 Repository Horizon







Figure D-3 WIPP Underground Facilities







Figure D-4 Underground Escape and Evacuation Map







Figure D-7 Designated Underground Assembly Areas







Figure G-1 Location of Underground HWDUs and Anticipated Closure Locations





Figure G-6 Approximate Locations of Boreholes in Relation to the WIPP Underground





Figure G2-1 View of the WIPP Underground Facility




Figure N-4b Disposal Room Sample Head Arrangement for Panel 8
