

WIPP POLICY
ADVISORY COMMITTEE

1. PURPOSE OF THE COMMITTEE

Pursuant to its duties and powers contained in the Radioactive Materials Act, 74-4A-1 through 74-4A-19NMSA 1978, the Radioactive Waste Consultation Task Force establishes the Policy Advisory Committee on the Waste Isolation Pilot Plant Project whose purpose it shall be to conduct hearings concerning issues related to the WIPP project. The Committee shall summarize these hearings and make recommendations in reports that shall be submitted to the Governor, the Radioactive Waste Consultation Task Force and the Radioactive Materials Committee.

2. MEMBERSHIP

The committee shall consist of twelve (12) members from diverse geographical locations in New Mexico who shall represent the broadest possible spectrum of backgrounds and experience which might relate to nuclear waste disposal. Membership shall be selected from the New Mexico academic community, business, public interest groups, elected officials, industry, the scientific community or other appropriate sources. No member shall be a Department of Energy employee or contractor associated with the planning, construction, or operation of the proposed facility. The Chairperson and members, upon the advice of the Task Force, shall be appointed by the Governor and shall serve at his pleasure. Vacancies shall be filled on the basis of recommendations made by the Chairperson of the Task Force to the Governor.

3. FUNCTION OF THE COMMITTEE

(a) The Committee shall conduct a total of nine (9) hearings. The first three (3) hearing sites shall be Carlsbad, Albuquerque, and Roswell, the first hearing to commence within one hundred twenty (120) days of the appointment of the twelve (12) members of the Committee. The next six (6) hearing sites shall be determined by the Committee.

(b) The Committee shall then conduct the remaining eight (8) public hearings at approximately one hundred twenty (120) day intervals until all hearings are completed.

(c) Particular topics to be covered by the hearings shall be at the discretion of the Committee, but a suggested list of areas of concern follows: TRUPACT design, Congressional land withdrawal issues, transportation routes, state land acquisition, waste retrievability, geology and hydrology, RH-Tru and High Level Waste cask design and testing, proposed experimental programs, environmental monitoring, state on and off-site control of shipments, and other subjects directly related to the WIPP project.

(d) The Committee may prepare for the hearings by reviewing relevant documentation provided by the Task Force or by members of the public who have indicated an intent to testify at a hearing, and other appropriate sources.

(e) The Committee shall provide public notice thirty (30) days in advance of each hearing by publishing such notice in a newspaper of statewide circulation and in the most widely circulated newspaper in the city where each hearing is to be conducted, and by providing such notice to any individual or group who have indicated an interest in receiving such notice.

(f) The Committee may solicit testimony from persons qualified in an area that the Committee wishes to hear testimony concerning.

(g) The Committee shall conduct the hearings for at least one (1) day but no longer than three (3) days.

(h) The Committee shall instruct its staff to take notes on each hearing for purpose of the Committee's summary later.

(i) Within one hundred twenty (120) days of the conclusion of each hearing, the Committee shall prepare a summary of the issues raised during that hearing and make recommendations to the Governor, the Task Force, and the Radioactive Materials Committee. Said report shall be considered public information and shall be made available on request.

(j) The Committee Chairperson shall keep the Task Force Chairperson informed of any issues that require immediate attention of the State agencies reviewing WIPP.

4. FUNDING

The Committee shall be funded by the Environmental Improvement Division through the DOE/HED contract which funds the EEG. Funding shall be sufficient to reimburse members for travel and per diem and to provide for a full-time Administrative Secretary. Expenditures shall be at the direction of the Committee Chairperson and shall be reported quarterly to the Director of EID.
