NOTICE OF RECEIPT OF
HAZARDOUS WASTE PERMIT APPLICATION
WASTE ISOLATION PILOT PLANT
EPA NO. NM4890139088

The State of New Mexico is authorized to operate a hazardous waste management program in lieu of the Federal program for those portions of the Resource Conservation and Recovery Act (RCRA) in effect before the enactment of the Hazardous and Solid Waste Amendments of 1984 (HSWA). The HSWA imposes additional requirements on hazardous waste management facilities that will be administered by the U. S. Environmental Protection Agency (EPA) until the State of New Mexico receives additional authorization for those requirements. Under authority of the New Mexico Hazardous Waste Act (Section 74-4-1 et. seq. NMSA 1978, as amended, 1993) and the New Mexico Hazardous Waste Management Regulations (20 NMAC 4.1), the New Mexico Environment Department (NMED) reviews RCRA permit applications from facilities desiring to treat, store, and/or dispose of hazardous waste.

On May 26, 1995, the New Mexico Environment Department (NMED) received a revised RCRA Part B Permit Application (Revision 5) from the Department of Energy (DOE) for the disposal of hazardous waste at the Waste Isolation Pilot Plant (WIPP). DOE provided this application to comply with a September 2, 1994, NMED order to submit a complete revised application that more accurately reflected future WIPP activities. The application is available for public review during normal business hours at the locations listed below.
