The New Mexico Environment Department (NMED) is issuing a draft Order dated June 21, 2006 to the Giant Refining Company, Bloomfield Refinery; owned by the San Juan Refining Company and operated by Giant Industries Arizona, Inc., pursuant to NMSA 1978 §§ 74-4-10.1 and 74-4-13 of the New Mexico Hazardous Waste Act. This draft Order contains investigation and cleanup requirements of environmental contamination caused by refinery operations, and a schedule for its implementation at the refinery.
