The Hazardous Waste Bureau has completed the calendar year 2000 Annual Unit Audit for your facility pursuant to 20.4.2.201.1 NMAC. An invoice for the Annual Hazardous Waste Management Business Fee (Annual Fee) is enclosed including the tabulations for the Annual Unit Audit.



The written request shall be accompanied by a copy of the invoice being contested and shall set forth the grounds upon which the appellant disagrees with the assessment.”
