The New Mexico Environment Department (NMED) has received the *Investigation Work Plan Up-gradient MKTF Wells* (Work Plan), dated August 2018 and received September 19, 2018. The NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. NMED will review the submittal after the appropriate fees have been received. The fee invoice is attached to this letter. 
