The New Mexico Environment Department (NMED) has received the *RCRA Facility Investigation Report SWMU 62, Former Sewage Treatment Plant Imhoff Tank, and SWMU 79, Sludge Beds at the Sewage Treatment Plant*, dated May 2018 and received May 29, 2018.
