The New Mexico Environment Department (NMED) has received White Sands Missile Range (WSMR) document, *2020 Groundwater Frequent Monitoring Report, SWMUs 38 & 39, HELSTF Construction Landfill, SWMU 143, HELSTF Storage Yard Chromium Spill Site, SWMU 154, HELSTF Systemic Diesel Spill Site*, dated January 2021 and received May 17, 2021.
