The New Mexico Environment Department (NMED) has received White Sands Missile Range (WSMR) document, *RCRA Facility Investigation Work Plan, SWMUs 55, 56, and 56a, Hazardous Test Area Open Burn/Open Detonation Pits*, dated March 2021 and received May 13, 2021.
