The New Mexico Environment Department (NMED) has received White Sands Missile Range (WSMR) document, *2020 Groundwater Monitoring Report SWMU 119 Stallion Range Landfill and SWMU 120 Former Stallion Center Landfill*, dated November 2021 and received December 14, 2021. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. 

If payment is transmitted electronically, then you must submit a letter to Mr. Dave Cobrain, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
