The New Mexico Environment Department (NMED) has received White Sands Missile Range (WSMR) document, *2021 Groundwater Frequent Monitoring Report SWMU 114, 115 Rhodes Canyon Landfill*, dated March 2022 and received April 4, 2022. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. 

If payment is transmitted electronically, then you must submit a letter to Mr. Dave Cobrain, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
